- All services require street-level or dock access and elevator access for multi-floor facilities. Additional fees may apply when any of these are unavailable requiring navigation and handling on stairways.
- Customer acknowledges Additional Services, Fees, Terms and Conditions are available at www.KARDShredding.com. Charges and fees are subject to change with 30 days' written notice after the first anniversary of this Order. Past due accounts are subject to monthly handling fee of \$35 plus 18% annual interest and loss of multiyear discounts, retroactively applied to the invoice's service date. The Customer acknowledges their responsibility to pay all fees at time of service, plus all collection costs on past due amounts, including court costs and attorney fees without further notice.

- All invoices are due on receipt within a grace period of 30 days. Customer acknowledges that KARD's entire liability is limited to the price charged and paid for services rendered.
- Unless this order is terminated at least 30 days prior to its anniversary, this Order shall automatically be renewed for additional one-year periods at then-current prices and remains in effect unless otherwise noted or terminated by one or both parties with and without cause.
- Prohibited and contaminated materials described on KARD's website shall be treated as OTHER WASTE and subject to adjusted pricing. Containers are expected to be at least 75% full at the time of pickup or subject to up charge of 20% and loss of multiyear discounts.
